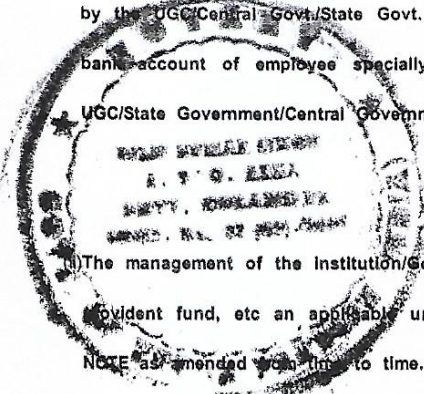


CERTIFICATE FROM THE MANAGEMENT/GOVT. INSTITUTION
